RULES AND REGULATIONS

1. The name of the Society : SRI VENKATESHWARA EDUCATIONAL SOCIETY JILLELAGUDA
2. Location of the Society : : # 1-133, Jillelaguda, Saroornagar (M),
Ranga Reddy District – 500 097.
3. **MEMBERSHIP** : Those who are interested in the aims of the society can become members subject to the verification of the bonafied and by approval of the executive committee.
The Category of Members are:
- a) Founder Members
 - b) Life-Members
- a) **FOUNDER MEMBERS** : Founder Members are those persons who are members at the time of registration of the society. Every founder member nominate his/her successor. If he/she does not nominate, his/her eldest progeny shall be the successor.
- b) **LIFE MEMBERS** : Every person who pay sum of Rs.25000/- in lumpsum shall be called a Life Member.
4. The Organizational Structure of the Society shall be as follows :
- A) General Body
 - B) Executive Body
- a) The General Body consists of
- i) Founder Members
 - ii) Life Members
- b) The Executive Body consists of five (7) Members elected by the General Body.
5. **THE EXECUTIVE BODY SHALL ELECT THE FOLLOWING OFFICE BEARERS**
- i) President
 - ii) Vice-President
 - iii) General Secretary
 - iv) Joint-Secretary
 - v) Treasurer

FUNCTIONS OF THE GENERAL BODY:

- i) The annual General Body will meet once in a year i.e., in the month of December.
- ii) To pass the budget for ensuing year and approve the statement of accounts of the previous year.
- iii) To approve the annual report of the activities of the society.
- iv) To elect the Executive Committee.

7. FUNCTIONS OF THE EXECUTIVE BODY:

The meeting of the Executive Committee may held from time to time. In case of an ordinary Executive Meeting, three days notice, and one day notice for emergency meeting shall be given. The notice shall specify the date, time, place and agenda. The meeting of the Executive Committee shall be called by the Secretary-cum-Correspondent.

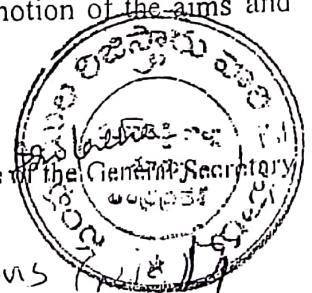
The term of the Executive Body and Office bearers shall be two years (i.e., From 1st February to 31st January of second succeeding year). In case of emergency the Secretary is empowered to extend the term of Executive Committee for one month only. However, the new Office Bearers will remain in the Office as per the original schedule.

Without Prejudice to the General power conferred, The Executive Committee is entitled, empowered and authorized to do the following:

- a) The Executive Committee shall be responsible for implementing the decisions of the General Body.
- b) The Executive Committee shall initiate the constitution Bye-Laws etc., for various institutions and associate organizations sponsored by the Society and shall be approved by 2/3re majority of the present and visiting strength of the General Body.
- c) In case of vacancy in the Executive Committee due to resignation of members or otherwise, the Executive Committee shall fill the vacancy for the rest of the term by nominating members from the General Body.
- d) In the Absence of the President and Vice-President, the Executive Committee shall elect a member from among its members present to preside over the meetings of the Executive Committee.
- e) The Executive Committee co-opts such of those persons whose services are deemed necessary to the society as honorary members of General Body and Executive Committee.
- f) To use or constitute legal proceedings.
- g) To decide the admission of new members of the society.
- h) To constitute committees and adhoc committee.
- i) To receive and spend contributions, donations, subscriptions, gifts etc., and appeal for the same.
- j) To start, establish, arrange aid or assist libraries, lending libraries, consultation and information centers, educational institutions, reading rooms, hostels, health centers, play grounds, and make Bye-Laws for their administration.
- k) To call or arrange for meeting conferences, assemblies, study circles etc.,
- l) To take the management of the institutions working for the promotion of the aims and objectives of the Society.

- m) To manage the day-to-day affairs of the society, its dependents and sided institutions.
- n) To delegate all or any of its powers under the constitution to any office bearers of members of the society.
- o) To prescribe fee for life members from time to time as per the existing conditions.
- p) To use scholarships to the needy students.
- q) To do all activities and deeds and execute all such powers, which are not specifically given under this constitution.

EXECUTIVE COMMITTEE MEETINGS :

- a) The Executive Committee shall meet at least two times in a year at an interval of not more than six months between each meeting.
- b) The Executive Committee can meet as often as the General Secretary in consultation with the President thinks, necessary in addition to the statutory prescribed meetings.
- c) If any fore members of the Executive Committee give a requisition in writing for the convening of the meeting, the President shall immediately cause the meeting to be so convened.
- d) The agenda shall be fixed by the General Secretary with the approval of the President.
- e) The quorum for the Executive Committee meeting shall be 3 members and includes Office Bearer also. The matters will be decided by majority of the members of the present.
- f) The President shall have the costing vote in case of a tie.
- g) The minutes of the Meeting shall be recorded by the General Secretary and signed by the President. A copy of this shall be circulated to all members of the Committee.
- h) Officially and legally the General Secretary represents the Society.
- i) In the absence of the President, the Vice-President shall preside over the meetings of the General Body and the Executive Committee.

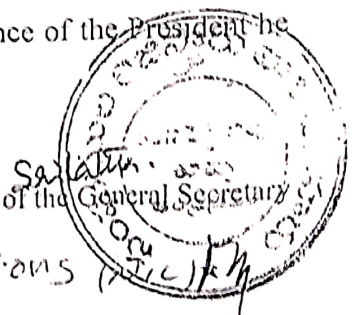
8. POWERS AND FUNCTIONS OF THE PRESIDENT:

- a) He presides over all the meetings of the General Body and Executive Committee. He can cast his vote in the case of tie. He can supervise all branches of the society.
- b) On behalf of the society, the President or General Secretary shall negotiate, enter into agreements, sign old documents etc., with third parties.
- c) To take or give on lease any immovable property, to purchase, to sell, transfer, change, mortgage or deal in property both movable and immovable belonging to the Society.
- d) To take loans and invest the funds of the society on such terms and conditions, as it deems fit and necessary.
- e) To open Bank Account with private or Nationalized Bank and to arrange to operate thereof. The accounts will be operated either by President or by General Secretary.

9. POWERS AND FUNCTIONS OF THE VICE-PRESIDENT:

He shall assist the President in discharging his functions. In the absence of the President he will perform the duty of the President as entrusted by the President.

POWERS AND FUNCTIONS OF THE GENERAL SECRETARY:

- a) To do all executive work with society.
- b) To implement all resolutions and decisions of executive committee and the general body.
- c) To manage, advise, direct, supervise and control the day to day administration of the society and its associated organizations and institutions.
- d) To appoint and remove persons in various institutions as per the decisions of the Executive Committee and the General Body.
- e) The General Secretary shall summon and attend all meetings of the General Body and Executive Committee by getting permissions from the President.
- f) He has to record all such meetings in the minutes book.
- g) He shall be incharge of all records and documents of the society.
- h) On behalf of the society President or General Secretary shall negotiate, enter into agreements, sign old documents etc., with third party or parties.
- i) He shall prepare periodic reports regarding the activities of the society to be placed before the annual General Body meeting.
- j) In all circumstances he shall act and discharge his duties under the directions of Executive Committee or General Body.
- k) He shall prepare and submit the annual budget for the approval of the General body and see that it is approved on or before 31st March.
- l) To take or give on lease any immovable property, to purchase, to sell, to transfer, change, mortgage or deal in property both movable and immovable belonging to the Society.
- m) To take loans and invest the funds of the Society on such terms and conditions, as it deems fit and necessary.
- n) To open bank Account with Private or Nationalized Banks and to arrange to operate thereof the accounts will be operated either by the President or by General Secretary.
- o) To appoint an Auditor.

11. POWERS AND FUNCTIONS OF THE JOINT-SECRETARY:

He has to do the work as entrusted by the Executive Committee. He has to assist the Secretary cum Correspondent in discharging his duties. In the absence of the Secretary cum Correspondent he can perform the duties of the General Secretary.

12. POWERS AND FUNCTIONS OF THE TREASURER:

He is the responsible for all the financial transactions relating to the society. He has to maintain the account properly along with the vouchers. He has to prepare the budget and expenditure statements of the society with the guidance OF THE General Secretary. He has to prepare the accounts of the Society jointly with the Secretary-cum- Correspondent or President.

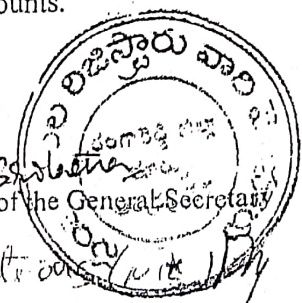
13. MAINTENANCE OF ACCOUNTS:

FUNDS:

The Funds of the Society should be the donations from the public grants and from the State or Central Government.

The funds of the society shall be spent only for the attainment of the objectives of the society and no portion there of shall be transferred directly or indirectly to any of its Members.

16. AMENDMENTS:

No amendments or alterations shall be made in the purpose of the association unless it is voted by 2/3^{re} of its members present at a special meeting convened for the purpose and confirmed by 2/3^{re} of the members present at a second special meeting.

17. LIABILITIES OF THE SOCIETY AND MEMBERS :

- a) The Liabilities of the society or limited to the fixed and financial assets of the society.
- b) The members of the society are not responsible for the liabilities for the society. The members will however be responsible for the personal guarantees given on behalf of the society for any loans raised by the society.

18. FINANCIAL YEAR AND AUDIT :

- a) The financial year of all integrated Educational society shall be 1st April to 31st March.
- b) Chartered Accountants shall be appointed to audit the accounts of the Society.

19. TERMINATION OF MEMBERSHIP:

If any member from the General Body is found doing work against the interest of the Society he or she liable to be removed from the society after a resolution passed in the General Body with 2/3rd majority.

The membership of the society shall cease.

- a) on registration ; or
- b) On adjudication as insolvent ; or
- c) On death ; or
- d) Upon conviction by Court of Law on any offence involving moral Turpitude ; or
- e) On failure to pay subscription for two consecutive years ; or
- f) On the passing of a Resolution by the Executive Committee.

20. WINDING UP:

In case of society has to wind up, the properties and funds of the Society that remains after full satisfaction of the liabilities of the society will be transferred or paid to some other Society or Institute with similar aims and objectives.
